## CAMP WHITEWATER, INC. CONSENT AGREEMENT AND RELEASE FORM

If I cannot be reached, I hereby authorize either the Camp Director or his direct subordinate to make emergency medical decisions for my child. If there are any activities I do not want my child to be involved in, I will list them on the Confidential Health Form.

I UNDERSTAND AND HEREBY AGREE TO ASSUME ALL THE RISKS WHICH MAY BE ENCOUNTERED DURING SAID YOUTH CAMP, INCLUDING ACTIVITIES PRELIMINARY AND SUBSEQUENT THERETO. I do hereby agree to hold Camp Whitewater Inc., Winona, MN, and its agents and volunteers, harmless from any and all liability, actions, causes of actions, claims, expenses, and damages on account of injury to my child or property which I now have or which may arise in future connection with the youth camp or participation in any other associated activities.

I expressly agree that this release, waiver, and indemnity agreement is intended to be broad and inclusive as permitted by law of the **State of Minnesota** and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. This release contains the entire agreement between the parties hereto and the terms of this release are contractual and not a mere recital.

I further state the I **HAVE CAREFULLY READ THE FOREGOING RELEASE AND KNOW THE CONTENTS THEREOF AND I SIGN THIS RELEASE AS MY OWN FREE ACT.** This is a legally binding agreement that I have read and understand.
